Creates quick backup for all the data from various log tables at once.
  - DTKTBLTRUNCATE.bat  
Formats (deleting all data and releasing extended area) every log table.

## User Operation Log Search Function

This function enables user-based searching of logs from the Log Viewing Database by using the Log Viewer.

The function enables lateral searching of logs of all the management servers that constitute the system on the basis of user information. The logs can be searched on the basis of user information of the user policy; therefore, the conventional management methods can be used as they are. Moreover, a log of a user not specified in the user policy can also be searched on the basis of the user information extracted from the log.

This function enables to manage individually owned smart devices as well as the business applications used in the individually owned smart devices.

Also use the window title obtaining log to identify the application.

\*2: Application startup prohibition can be set per process. Therefore, if a common process will run multiple applications, such as Windows Store apps, you cannot set startup prohibition per application. You can prohibit startup of all Windows Store apps by setting startup prohibition for the common process.

## **Improvement of Web Upload Prohibition Function**

In an earlier version, it was not possible to prohibit upload upon display of the file selection dialog even if Web upload was prohibited. With this version, the display of file selection dialog is disabled and it is possible to prohibit the file upload.

## **Improvement of Report Output Tool**

In an earlier version, the log information of the report output from the report output tool would be displayed in the order of operation date and time. With this version, in addition to the order of operation date and time, the log information can also be displayed in the order of group + terminal + user, and the display order can be selected in the report output tool.

The user name and domain name of every log is recorded in the information used for verification of Microsoft account. A local user policy can be applied even when logging on with a Microsoft account. Moreover, Microsoft account can be assigned as a target of Logon Prohibition.

Character in surrogate pairs are counted as 2 characters because 1 such character is of 4 bytes.

Combined characters have 1 character of N bytes. Such characters are therefore counted as (N/2) or the denominator may even be a higher value in some characters.

## 2.2 Setup

Modify the setup as follows.

### Incompatibility when transferring from V14.3.1 or earlier

#### Restart the OS

You must restart the OS after you install or uninstall the Management Server and Management Console.

#### Install from a network medium

From V15.0.0, you can install Management Server, Management Console, log analyzer server, report output tool directly from a network medium.

#### Install Management Server

Modify the installation target initial value of the database-related file.

In the old version, the initial value folder is the same as the other folder (backup original file saving folder, etc.), but from V13.3.0, the single folder of database-related file will be the initial value.

From V15.0.0 onwards, you can install a Relay Server by going to the "Setup" window. You can uninstall the Relay Server by going to "Uninstallation and management (middleware)".

### Incompatibility when transferring from V12

Modify the installation of the Client (CT).

#### Silently install to Client (CT)

Modify the parameter during silent installation.

For details on parameters after modification, refer to "Install the Client (CT)" in the *Installation Guide*.

## 2.3 Management Server

---

### Communication between Management Server/Master Management Server and Management Console

#### Incompatibility when transferring from V15.0.1B or earlier

When connecting a Management Server/Master Management Server to a Management Console, the server first verifies the address to be connected to. When restarting the service of a Management Server/Master Management Server, you must therefore terminate the operations of all the Management Consoles and then reconnect the consoles after the service resumes.

The Management Server/Master Management Server cannot connect to a Management Console while the console is still running. If connection cannot be established, then terminate the Management Console and try to re-connect.

The time required for the Management Console to stop its operations is:

**Server Settings Tool > Management Server Settings > Timeout value of communication between servers**

## Communication between Management Server and Master Management Server

Incompatibility when transferring from V15.0.0A or earlier

## Communication between Management Server/Master Management Server and Client (CT)

Incompatibility when transferring from V15.0.0A or earlier

Name resolution of the Management Server/Master Management Server must be done for each machine. If name resolution fails, then communication cannot be established between the Management Server/Master Management Server and the Client (CT).

Incompatibility when transferring from V14.3.1 or earlier

The communication between the Management Server/Master Management Server and the Client (CT) is encrypted. The unencrypted communication, such as the one with the client (CT) for which the communication-related encryption corrections have not been applied is thus restricted.

- Either the corrections applicable after September 2014 need to be urgently applied to the clients with versions V13.3.0-V14.3.1 or version upgrade from these older versions is necessary.
- The clients with versions older than V13.2.1 cannot be used without upgrading them to V15.1.
- After upgrading the version of the Management Server to V15.1, only two clients, namely V15.0 and V15.1, can be newly installed.

For notes on steps to be followed when the Management Server/Master Management Server and the Client have different versions, refer to *Installation Guide*.

## Conversion of Old Database command

## Database (DBMS)

Modify the database (DBMS) as follows.

### Incompatibility when transferring from V13.0.0~V14.3.1

The commercial version of Symfoware can no longer be used as DBMS (Database Management System).

### Incompatibility when transferring from V12

A DBMS is modified as a unique DBMS (product built-in) from a Microsoft(R) SQL Server 2000.

As the modification of DBMS occurs, modifications also occur to the search result of the Log Viewer.

- In the search result, hiragana and katakana are processed as special characters. (In V12, they are processed as the same characters.)
- In the search result, multi-byte and halfwidth alphanumeric characters are processed as special characters. (In V12, they are processed as the same characters.)

### Incompatibility when transferring from older versions

As a result of modifying the database, DB-related service names are changed, as follows:

## Server settings tool

In this case, if the password entered when installing the Client (CT) is different from the Client management password, then the Client is not registered into the Management Server.

If you change the password by going to the **Terminal Operation Settings** window of the Management Console, in the earlier versions, the password of the Android agent registered on the Management Server/Master Management Server for which the password was changed used to get changed. However, from this version the password of the Client registered on the Management Server/Master Management Server for which the password was changed will also change. The password set when installing the Client is overwritten.
